**CONDITIONS FOR: DINGHY LAUNCHING, MOTOR BOAT LAUNCHING &  
PERSONAL WATER CRAFT LAUNCHING  
SEASON TICKET**

1. Season Tickets are valid for use only by the holder in person with the boat/PWC named on the ticket. They are NOT TRANSFERABLE between either craft or individuals.
2. Season Ticket holders who change craft must return their season ticket to the Pier and Foreshore Section for amendment. There will be a £5.00 administration charge made for issue of amended tickets.
3. In the event of misuse of Season Tickets, the Pier and Foreshore Section shall have the authority to cancel the ticket and the holder shall not be entitled to any refund of the fee paid.
4. P.W.C. may only launch from the slipway at Ness Road. (P.L.A. Byelaw 51(1)(b))
5. The slipway is owned and managed by Southend on Sea Borough Council.
6. All P.W.C., DINGHY and MOTOR BOAT users are required to hold Third Party Liability Insurance.
7. All P.W.C., DINGHY and MOTOR BOAT users must wear either a life-jacket or a buoyancy aid.
8. It is a P.L.A. requirement that the minimum age to be in control of any P.W.C. and Motor craft is 16. (P.L.A. Byelaw 49)
9. An observer is required on the craft at all times when towing an object or person. (P.L.A. Byelaw 51(3) (b))
10. When launching from the Ness Road slipway, P.W.C. users should proceed in a southerly direction for  $\frac{1}{4}$  of a mile, keeping to the east of the buoyed lane, and all craft should not exceed the 8 knots (approx 9 m.p.h.) restriction until  $\frac{1}{4}$  of a mile from shore.
11. Having reached a distance of  $\frac{1}{4}$  of a mile from the shore, no speed limit need be observed.
12. Note: Sections 41 and 42 of the Southend-on-Sea Corporation Act, 1960 and Section 76 of the Public Health Act, 1961 supercedes P.L.A. Byelaw 51(1)(b). This means that no person can operate a P.W.C. within  $\frac{1}{4}$  of a mile of a public beach.
13. P.W.C. users can only recover their craft through the buoyed lane. They should remain at least  $\frac{1}{4}$  of a mile from the shore until reaching the lane and then reduce their speed to 8 knots or less before heading north, again keeping to the east of the buoys.

**The above list of rules and regulations has been produced as a guide to help keep jet ski-ing, jet biking and Motor Boating a safe activity. However, it is Council policy to prosecute Byelaw offenders. Fines for those successfully prosecuted could amount to £5000 per offence**
